Time Magazine Reports Data Breaches Up 20% This Year

There is no doubt identity theft is on the rise. So far this year, the number of data breaches that have put individuals at risk has gone up by 19%. In 2014, there have been over 10.9 million records exposed and over 381 data breaches have occurred.

The main sector targeted has been business, specifically the health care and governmental sectors.

Identity theft has been on the rise since 2010. The past year has been significant with data breaches occurring within big corporate names like Target, Michaels, eBay, PF Changs, and

Neiman Marcus.

A data breach occurs when a name and another identifying piece of information, such as a Social Security number, are put at risk of being seen by someone not authorized to see it.

Florida Has New Data Protection Law As of July 1, 2014

Florida businesses will face increased data breach risk compliance as of July 1, 2014. The Florida Information Protection Act of 2014 (FIPA) took effect as of July 1, 2014. FIPA replaces Florida's existing data breach notification law.

The main changes are that it added health information to the type of information protected and reduced the time to report a breach from 45 to 30 days. Covered entities are also required to report data breaches that affect 500 or more people to the Department of Legal Affairs.

FIPA governs "covered entities." A covered entity is a commercial entity that acquires, maintains, stores or uses personally identifiable information. A "breach" triggering FIPA is the unauthorized access of data in electronic form containing personally identifiable information (PII).

Covered entities are required under FIPA to notify the Florida Office of the Attorney General in the event of a breach. FIPA also requires notice to the individuals affected by the breach within 30 days. A covered entity that does not properly notify affected individuals or the Attorney General may be fined up to \$500,000 per breach, depending on the number of days in which the covered entity is in violation of the FIPA.

What is personally identifiable information (PII)?

Under FIPA, PII is defined as a first name or first initial and last name in combination with any of the following:

- Social security number
- Driver's license or identification card number, passport number, military identification number, or other similar number issued on a government document used to verify identity
- Financial account number or credit or debit card number, in combination with any required security code, access code, or password that is necessary to permit access to an individual's financial account
- Information regarding an individual's medical history, mental or physical condition, or medical treatment or diagnosis by a health care professional
- Individual's health insurance policy number or subscriber identification number and any unique identifier used by a health insurer to identify the individual

PII also includes a username or email address in combination with a password or security question and answer that would permit access to an online account.
