Tampa General Breach Affects Almost 700 Patients

Approximately 700 patients treated at Tampa General Hospital have been identified as victims of a data breach. On August 14, 2014 the Tampa Police Department notified Tampa General that hospital records had been obtained during a traffic stop and arrest of an individual.

The arrested individual was not an employee of Tampa General, however, the records were traced back to a former employee who was accessing the records without authority. That employee was terminated by Tampa General.

The personal information stolen included patients' names, addresses, dates of birth, admitting diagnoses, names of insurance payers, and, in some instances, Social Security numbers. What happened? The personal information may have been accessed by a former employee.

Update on Some Major Retailer Data Breaches

JP Morgan Breach Affected 76 Million Homes

The largest US bank has disclosed that a breach earlier this year has affected 76 million homes and 7 million businesses. The bank announced that hackers were able to obtain names, addresses, phone numbers and email addresses of customers who used Chase's websites or those who used a mobile app.

Chase has posted an FAQ for customers on Chase.com, advising them that they don't need get new cards or change passwords (though, honestly, it never hurts to change your password on a regular basis).

Home Depot

A month ago, 56 million credit card numbers were stolen from Home Depot.

Many in the security community suspect the attackers were in Russia or Eastern Europe, but there's no way to know for sure. What is known is that malware skimmed off credit and debit card information, went undetected for six months.

The news broke in September, when someone put a batch of cards for sale on a criminal Internet site that trafficked in stolen financial information.

EBay

145 million records were breached earlier this year in connection with an eBay breach.

EBay informed users in May that it was aware of unauthorized access to eBay systems that may have exposed some customer information. The company said there was no evidence that financial

data was compromised. The company subsequently advised users to change their eBay passwords as the attack compromised a database containing eBay user passwords.

EBay now faces a class action lawsuit in federal court.

Target

December of last year Target experienced a large data breach that affected 110 million people.

Just before last Thanksgiving, someone installed malware in Target's security and payments system designed to steal every credit card used at the company's 1,797 U.S. stores. At the critical moment-when the Christmas gifts had been scanned and bagged and the cashier asked for a swipe-the malware would step in, capture the shopper's credit card number, and store it on a Target server commandeered by the hackers.

These are just a few of the recent data breaches. Others include PF Changs, Neiman Marcus, Michaels and more.
