

It is believed that an employee of Family Central, a non-profit contractor, stole the personal information. The breach is believed to have affected over 100 individuals receiving subsidized child care.

Last October when maintenance workers threw out four boxes of Independence Blue Cross members' records it caused a data breach affecting 12,500 of its more than 2.5 million members.
