Shred or hide all documents (credit card statements, bills, credit card receipts, tax returns, unused checks, canceled checks, and credit reports) that contain account information, Social Security numbers, PINs, or sensitive information. Also shred or otherwise destroy expired credit cards and driver's licenses, and never leave receipts at bank machines, bank counters, trash receptacles, or unattended gas pumps.

\$750K Settlement Points To The Need For Strong HIPAA Policies

On September 2, the U.S. Department of Health and Human Service's Office for Civil Rights (OCR) reported that it agreed to settle potential violations of HIPAA with the Cancer Care Group for a whopping \$750,000!

A bag that contained the employee's computer and unencrypted back-up media that contained the names, addresses, dates of birth, Social Security numbers, insurance information and clinical information of approximately 55,000 current and former Cancer Care patients was stolen.

OCR said the Cancer Care Group did not have a written policy to routinely remove back-up media from devices that left the clinics, which contributed to the breach.

Is Your Child Already A Victim Of Identity Theft?

According to a study by Carnegie Mellon University's CyLab, children are 51 times more likely to be a victim of identity theft than adults.

The fact is that approximately 30% of child identity theft is done by the child's own family members. TransUnion is experimenting in Utah with a program that puts the Social Security numbers of minor children into a database that could be checked by credit reporting bureaus, the IRS and others before doing business with someone using that Social Security number.

Responsible parents should make sure that any records containing their children's personal information such as their Social Security numbers be locked away and secure from the inquiring eyes of other family members.
